Make Summer Reading Donations Available To Spend: As she has in previous years, Mrs. Heller solicited donations from area business to support programs for this year's Summer Reading Program. We have been pleasantly surprised by the generous donations but had not budgeted for them in this year's appropriation. To make the money available to spend this year, we would like to transfer an amount equivalent to the total donations into the Program Supplies account.

Monthly Library Statistics: Circulation counts of all kinds were down for May from last year. We also are down for year-to-date 4.9%. Comparing the total circulation for the first five months of the year for 2008-2013 one finds 2008 and 2009 much higher than 2010-2012 which three years had pretty much the same totals for the first five months. The 2013 five-month total is below that of any of those years. On the other hand, the door count totals year-to-date are comparable to last year's and well above those of the preceding several years.
